Dear neighbor,

We consider it a privilege to be part of the Juniata Terrace and are happy to be part of your community. In a recent Church Governing Board meeting we have chosen to take action regarding the use of our parking lot at 50 Hudson Avenue. As a valued neighbor we want to communicate the upcoming changes that may have an impact on you. Due to increased growth in our church and the need for parking, we will be posting our parking lot, but would like to offer a free, permit based system to our neighbors. Parking for any use other than church related functions will be prohibited unless a permit is displayed with the registered vehicle. *Enforcement of the posting will begin one week after signage is installed which will be mid-October.*

Enclosed is an application to apply for a free parking permit. When displayed on your mirror this will allow you to park in our lot except for designated times each week and special circumstances throughout the year. The application requires you to give current contact information which will allow us to communicate with you when special circumstances are going to occur.

Please note, although the parallel parking spaces on the outside of the guardrail along Hudson Avenue are part of our property, we are not requiring a permit for those spaces. We would also like to continue offering our lot for use during events that take place at the park (ex. Terrace Tigers) as long as it does not conflict with our usage. During those events we will communicate with event leaders the invitation to have guests in our parking lot at those times.

The Lewistown Christian and Missionary Alliance Church known hereafter as, "the church".

- \_\_\_\_\_ I understand a permit is only valid for non-commercial vehicles
- \_\_\_\_\_ I agree to notify the church immediately of any changes to the above given information
- \_\_\_\_\_ I understand this permit only allows parking in "Lot B" (north lot toward Wilsons)
- \_\_\_\_\_ I understand during the following times, parking with a permit is NOT permitted  
*(parking only for church events during these times)*
- Sundays / 6:00am – 12:00 noon
  - December 24 / 3:00pm – 9:00pm
  - Special events that will be communicated in advance via text *(ex. weather events, church functions, parking lot maintenance, etc.)*
- \_\_\_\_\_ I agree to keep my vehicle registration and inspection current as defined by PA law
- \_\_\_\_\_ I agree to keep my parking area free of trash, vehicle debris, and vehicle fluids
- \_\_\_\_\_ I understand the permit may be revoked at any time at the discretion of the church
- \_\_\_\_\_ I understand that violations to this agreement may result in my vehicle being towed at my expense (ex. parking during non-permitted times, failure to display permit, etc.)

*I agree to hold harmless, indemnify and defend the church (including the church agents, employees, and representatives) from any and all liability for injury or damage including, but not limited to, bodily injury, personal injury, emotional injury, or property damage which may result from any person using the above described premises, its entrances and exits, and surrounding areas, for User's purposes, regardless of whether such injury or damage results from the negligence of the church (including the church agents, employees and representatives) or otherwise.*
